CAA Mobile App™ Contest – CONTEST RULES

ELIGIBILITY

1. The CAA Mobile App™ Contest (“**Contest**”) sponsored by CAA Club Group (operating as CAA Manitoba) (“**CAA**”) is open to persons who reside within the club territory of CAA Manitoba, and have reached the age of majority in the Province of Manitoba (18 years of age) as of the date of entry for the Contest with the following exceptions: CAA affiliates, partners, suppliers, representatives, agents, advertising and promotional agencies, the independent contest agency if any, and the household members and Immediate Family of any of the above are not eligible to participate in the Contest with respect to the “Monthly CAA Dollars® Prizes” as described below, but may enter to win the “Applause Points Prizes”
2. For the purpose of these Contest Rules, “**Immediate Family**” means spouse, mother, father, brother, sister, son or daughter, whether or not they reside in the same household.

HOW TO ENTER

3. No purchase necessary.
4. For CAA Members in good standing, in the club territory of CAA Manitoba as of April 5, 2021, to enter the Contest, visit the contest tile located in the CAA Mobile App to click on the link to submit your entry form by following the instructions provided.
5. For CAA Members who are unable to enter online, a Contest entry will also be accepted by mail to CAA Manitoba, 870 Empress Street, Winnipeg, Manitoba R3G 3H3 or by fax to 204-775-9989. The mail and fax entries should include the entrant’s first name, last name, complete mailing address including street address, city, province and postal code on a card or sheet of paper not exceeding 8.5 X 11” and submit to Attention: CAA Rewards Contests.
6. For CAA Employees, in the club territory of CAA Manitoba as of April 5, 2021, to enter the Contest, visit the contest tile located in the CAA Mobile App to click on the link to submit your entry form by following the instructions provided.
7. All entries must be received by CAA during the “**Contest Period**” beginning at 12:00:01 a.m. CDT on Monday, April 5, 2021 and ending at 11:59:59 p.m. CDT on Friday, December 31, 2021 (“**Contest Closing Date**”). For online and faxed entries, proof of sending is not proof of receipt. For mail-in entries, proof of mailing is not proof of receipt.
8. Only one (1) entry per person per month.
9. Entries that are incomplete, late, lost, and/or irregular in any way or sent by an unauthorized method are automatically void and will not be eligible or accepted. Entries will only be accepted as described herein and will not be accepted by any other means.
10. By entering the Contest, entrants agree to be bound by these Contest Rules.

THE PRIZES

11. For CAA Member in good standing, nine (9) monthly prizes are available to be won, each consisting of the following:

50 CAA Dollars®. Total retail value of each prize is \$50 CAD (individually a “**Monthly CAA Dollar Prize**”, collectively the “**Monthly CAA Dollar Prizes**”).

12. For CAA Employee, nine (9) monthly prizes are available to be won, each consisting of the following:

240 Applause Points. Total retail value of each prize is \$10 CAD (individually a “**Monthly CAA Dollar Prize**”, collectively the “**Monthly CAA Dollar Prizes**”).

13. The Monthly CAA Dollar Prizes or Monthly Applause Points Prizes must be accepted as awarded, and may not be assigned, transferred, substituted exchanged, refunded or redeemed for cash value. CAA reserves the right to substitute the Prizes with an item of equivalent or greater retail value in the event that the Prizes are unavailable due to circumstances beyond CAA’s control.

For CAA Members in good standing, nine (9) monthly CAA Dollar winners (“**Monthly CAA Dollar Winners**”) will be selected by random draw from all eligible entries received each month as specified in the Monthly Draw Table (each a “**CAA Dollar Draw**”). MONTHLY CAA DOLLAR WINNER CONFIRMATION

17. Selected entrants will be notified by telephone at the number provided at the time of entry. No communication or correspondence will be entered into, except with selected entrants.
18. To be confirmed a CAA Dollar Winner, the selected entrant must:
- (a) confirm compliance with these Contest Rules;
 - (b) accept a Monthly CAA Dollar Prize as awarded;
 - (c) correctly answer a mathematical skill-testing question without assistance of any kind, whether mechanical or otherwise, and within the time prescribed; and
 - (d) sign and return a Declaration of Eligibility and Release, in the form requested by CAA, within five (5) business days from the date of delivery thereof.
