WE ♥ MEMBERS CONTEST – CONTEST RULES

CONTEST PERIOD AND ELIGIBILITY

1. The We ♥ Members Contest ("**Contest**") sponsored by CAA Club Group (operating as CAA Manitoba) ("**CAA**") is open 12:00:01 a.m. CT on September 27, 2021 and ending at 11:59:59 p.m. CT on October 3, 2021 ("**Contest Period**") to persons who reside within the club territory of CAA Manitoba, and have reached the age of majority in the Province of Manitoba (18 years of age) as of the date of entry for the Contest with the following exceptions: employees and retirees of CAA and its affiliates, partners, suppliers, representatives, agents, advertising and promotional agencies, the independent contest agency if any, and the household members and Immediate Family of any of the above are not eligible to participate in the Contest. For the purpose of these Contest Rules, "**Immediate Family**" means spouse, mother, father, brother, sister, son or daughter, whether or not they reside in the same household.

HOW TO ENTER

2. Only one (1) entry per member.
3. NO PURCHASE NECESSARY. Eligible participants may enter the Contest in one (1) of two (2) ways:
 - a. Online Entry method: CAA Membership accountholders may enter online by visiting the website caamanitoba.com/membership/member-appreciation during the Contest Period, entering their valid CAA Membership number (Membership dues paid in full my membership expiry date), completing the required information by following the instructions provided and clicking "submit" to enter the Contest.
 - b) Eligible participants who do not wish to enter online may enter in-person at a CAA Manitoba store. Instructions will be provided onsite.
4. For online entries, proof of sending is not proof of receipt. Entries that are incomplete, late, lost, and/or irregular in any way or sent by an unauthorized method are automatically void and will not be eligible or accepted. Entries will only be accepted as described herein and will not be accepted by any other means.
5. By entering the Contest, entrants agree to be bound by these Contest Rules and all decisions of CAA, which shall be final and binding, without right of appeal, in all matters relating to this Contest and the awarding of the prize(s), including without limitation eligibility and/or disqualification of entries.

THE PRIZES

6. Thirty (30) prizes are available to be won (individually a “Prize”, collectively the “Prizes”).
 - a. One (1) grand prize valued at approximately \$2,385 CAD including:
 - i. \$1,000 CAD CAA Gift card (CAA gift card for use towards travel booked with CAA travel consultant, CAA Merchandise purchased in-store or via CAA Chat and/or towards annual CAA Membership fee)
 - ii. \$500 CAD Best Western gift card
 - iii. A set of luggage (Approximate retail value: \$600 CAD)
 - iv. Park'N Fly 8-day parking pass (Approximate retail value: \$169 CAD)
 - v. Free CAA Plus Membership (Approximate retail value: \$116 CAD)

 - e. Twelve (12) fifth prizes valued at approximately \$59.99 CAD each. Each consists of one (1) Lug tote bag, one (1) Lug water bottle, one (1) set of 2 Travelon luggage tags and one (1) set of Beekman 1802 soap.
 - f. Seven (7) daily prizes. Each consist of a Free CAA Membership (Approximate retail value: \$116 CAD)

The thirty (30) prizes are valued at \$5,210 CAD in total.

7. The Prizes must be accepted as awarded, and may not be assigned, transferred, substituted exchanged, refunded or redeemed for cash value. CAA reserves the right to substitute a Prize with an item of equivalent or greater retail value in the event that a Prize is unavailable due to circumstances beyond CAA's control. Prizes include delivery within approximately six (6) weeks. Any costs or expenses associated with the Prizes not specified herein will be the responsibility of Winners (as defined below).

9. The decision will be made by CAA at its head office located at 870 Empress Street, Winnipeg, Manitoba or if the head offices are closed the draw will take place remotely.
10. The odds of winning a Prize will depend on the number of eligible entries received during the Contest Period.

WINNER CONFIRMATION AND PRIZE CLAIM CONDITIONS

11. Selected entrants will be notified by telephone at the number provided at the time of entry, and are subject to verification by CAA and/or its designated representatives, in their sole discretion. No communication or correspondence will be entered into, except with selected entrants.
12. To be confirmed a Winner, the selected entrant must:
 - (a) confirm compliance with these Contest Rules;
 - (b) accept the Prize as awarded;
 - (c) correctly answer a mathematical skill-testing question without assistance of any kind, whether mechanical or otherwise, and within the time prescribed; and
 - (d) sign and return a Declaration of Compliance and Release of Liability and Publicity, in the form requested by CAA, within ten (10) business days from the date of delivery thereof, if requested by CAA and/or its designated representatives.
