CAA MANITOBA WE ♥ MEMBERS CONTEST - CONTEST RULES

CONTEST PERIOD AND ELIGIBILITY

1. The We ♡ Members Contest ("Contest") sponsored by CAA Club Group (operating as CAA Manitoba) ("CAA") is open 12:00:01 a.m. CT on September 27, 2021 and ending at 11:59:59 p.m. CT on October 3, 2021 ("Contest Period") to persons who reside within the club territory of CAA Manitoba, and have reached the age of majority in the Province of Manitoba (18 years of age) as of the date of entry for the Contest with the following exceptions: employees and retirees of CAA and its affiliates, partners, suppliers, representatives, agents, advertising and promotional agencies, the independent contest agency if any, and the household members and Immediate Family of any of the above are not eligible to participate in the Contest.
