DOMO® Gas For A Year Contest – CONTEST RULES

ELIGIBILITY

1. The DOMO® Gas For A Year Contest (“**Contest**”) sponsored by CAA Club Group (operating as CAA Manitoba) (“**CAA**”) is open to persons who reside within the club territory of CAA Manitoba, and have reached the age of majority in the Province of Manitoba (18 years of age) as of the date of entry for the Contest with the following exceptions: employees and retirees of CAA and its affiliates, partners, suppliers, representatives, agents, advertising and promotional agencies, the independent contest agency if any, and the household members and Immediate Family of any of the above are not eligible to participate in the Contest. For the purpose of these Contest Rules, “**Immediate Family**” means spouse, mother, father, brother, sister, son or daughter, whether or not they reside in the same household.

HOW TO ENTER

2. No purchase necessary. For CAA Members, in good standing, to enter the Contest, visit the website located at www.caamanitoba.com/domo and submit your entry form by following the instructions provided.
3. For CAA Members and Non-Members who are unable to enter online, a Contest entry will also be accepted by mail to CAA Manitoba, 870 Empress Street, Winnipeg, Manitoba R3G 3H3 or by fax to 204-775-9989. The mail and fax entries should include the entrant’s first name, last name, CAA Membership number (if applicable) complete mailing address including street address, city, province and postal code on a card or sheet of paper not exceeding 8.5 X 11” and submit to Attention: CAA Rewards Contests.
4. All entries must be received by CAA during the “**Contest Period**” beginning at 12:00:01 a.m. CDT on Monday, October 7, 2019 and ending at 11:59:59 p.m. CDT on Wednesday, September 30, 2020 (“**Contest Closing Date**”). For online and faxed entries, proof of sending is not proof of receipt. For mail-in entries, proof of mailing is not proof of receipt.
5. Only one (1) entry per person.
6. Bonus Entries: CAA Members, in good standing, can earn a bonus entry by purchasing fuel at any participating DOMO® gas location during the Contest Period. Valid CAA Membership card must be swiped at the participating DOMO® location to record a bonus entry. There is no limit on the number of bonus entries that can be earned during the Contest Period.
7. Entries that are incomplete, late, lost, and/or irregular in any way or sent by an unauthorized method are automatically void and will not be eligible or accepted. Entries will only be accepted as described herein and will not be accepted by any other means.
8. By entering the Contest, entrants agree to be bound by these Contest Rules.

THE PRIZES

9. One (1) grand prize is available to be won, consisting of the following:
 - a) Fifty-two (52) \$50 CAD DOMO® gas certificates. The total retail value of the grand prize is approximately \$2,600 CAD. (the “**Grand Prize**”); and

b) Twelve (12) monthly prizes to be won, consisting of one (1) \$50 CAD DOMO® gas certificate. (individually a “Monthly Prize”, collectively the “**Monthly Prizes**”).

10. The Grand Prize and/or Monthly Prizes must be accepted as awarded, and may not be assigned, transferred, substituted exchanged, refunded or redeemed for cash value. CAA reserves the right to substitute a Grand Prize or a Monthly Prize with an item of equivalent or greater retail value in the event that a Grand Prize or a Monthly Prize is unavailable due to circumstances beyond CAA’s control.

THE DRAW

11. Twelve (12) monthly winners (“**Monthly Winners**”) will be selected by a random monthly draw from all eligible entries received each month as specified in the Monthly Draw Table (each a “**Monthly Draw**”). A Monthly Draw will be made beginning with the first draw on November 1, 2019 and each month following, with the last Monthly Draw on October 1, 2020. Each monthly draw will be made by CAA at 870 Empress Street, Winnipeg, Manitoba.

12. One (1) grand prize winner ("**Grand Winner**") will be selected by random draw from all eligible entries received during the Contest Period. The decision will be made by CAA on Thursday, October 1, 2020 at 870 Empress Street, Winnipeg, Manitoba.
13. The odds of winning the Grand Prizes and/or a Monthly Prize will depend on the number of eligible entries received during the Contest Period. All Monthly Winners will be eligible to win the Grand Prize.

WINNER CONFIRMATION

14. Selected entrants will be notified by telephone at the number provided at the time of entry. No communication or correspondence will be entered into, except with selected entrants.
15. To be confirmed the Grand Winner or a Monthly Winner, the selected entrant must:
 - (a) confirm compliance with these Contest Rules;
 - (b) accept the Grand Prize and/or a Monthly Prize as awarded;
 - (c) correctly answer a mathematical skill-testing question without assistance of any kind, whether mechanical or otherwise, and within the time prescribed; and
 - (d) sign and return a Declaration of Eligibility and Release, in the form requested by CAA, within five (5) business days from the date of delivery thereof.
